



Dear Soccer Coach,

The Bluffton Soccer American Cup will be held on Saturday, May 18th and Sunday, May 19th, 2019. This tournament is for recreational based teams in for Rec U12, U15 divisions. If fewer than four teams, divisions may be combined. Each team will be guaranteed 2 games on Saturday in divisional play. Divisional winners will continue on to the semi final rounds on Saturday and/or Sunday. Cost of registration Rec U12 & U15 is \$250 per team. Additional entries will be held to safeguard against teams dropping out of the tournament. Rec teams will be open to all BSSL teams and approved non BSSL teams to keep the playing level fun for the kids. **Registration is DUE by April 20th, 2019!**

A team entry must consist of the following requirements before the April 20th deadline:

- Team Registration Page (pg. 2) with complete team payment and a copy of the team's Spring 2019 roster

The following is due at check in for the Tournament

- Registration form is completed with parent waiver signatures.

Once your team has been approved for the tournament, you will be sent another packet containing maps and schedule. (email or mail) The earlier teams register, the earlier teams will receive their packets, so please turn in your registration early. (Please make sure we can read them.)

Coaches and parents please remember; this tournament is to provide a positive experience for all participants; please refrain from abusive or demonstrative behavior towards opponents or officials. Our goal is for everyone to leave the tournament with a competitive but pleasant experience. Therefore, everyone's cooperation is needed. Let the kids enjoy themselves for this tournament weekend.

- A sportsmanship trophy (voted on by the referees) will be awarded to the team in each age group who displays the greatest amount of sportsmanship based on player, coach, and spectator behavior. 1st and 2nd place trophies per age group, as well as participation awards will also be handed out.
